Claiming the additional CTF support payments

\$2,000 payment

Immediate eligibility

Commencing Friday 24 April 2020, CTF will send an email to all employers currently in receipt of CTF's ordinary apprenticeship grants with information about the additional \$2,000 COVID Support Payment.

Employers will need to respond to the email and attach a current payslip for their apprentice/trainee for CTF to facilitate payment.

If the employer has already received an ordinary CTF apprentice support payment for that apprentice, prior to 23 April 2020, then no further eligibility criteria will be applied.

Employers who do not respond to CTF within two weeks of the email being sent will be followed up to ensure payments are received.

Pending eligibility

Employers who are yet to receive a CTF apprenticeship grant but employed and commenced their apprentice prior to 23 April 2020 will need to register their intent to claim [HERE](#) and will be subject to our ordinary eligibility criteria as described in our guidelines.

All additional COVID support payments assessed under the "pending eligibility" criteria shall become available (subject to our guidelines) after six (6) months from commencement with their current employer.

Ineligible for CTF COVID Support Payments

Employers who do not meet CTF's general eligibility criteria will not be eligible for the additional COVID support payments.

Employers of apprentices commenced after 23 April 2020 shall not be eligible for the additional COVID support payments but may be eligible for CTF's ordinary grant funding subject to our guidelines.

Monthly instalment

Monthly instalments are subject to the same criteria outlined above regarding the one-off \$2,000 payment.

In late May, CTF will email all employers currently in receipt of apprenticeship grants with information about the additional monthly payments.

Payments will commence from 1 June this year, backdated from 1 April and continue through until September 2020.



Employers will need to respond to the email and attach a current payslip for their apprentice/trainee for CTF to facilitate payment.

CTF will send reminders each month to employers for remaining monthly payments. Employers will need to provide CTF with current payslips each month to receive payments.

Apprentice training support - \$1,000 subsidy

All apprentices and trainees whose employers are currently receiving CTF grants will be eligible to receive a 100% reimbursement of all short training courses they complete, to a maximum value of \$1,000. These training courses must be in addition to any training that is part of an apprenticeship or traineeship training plan.

Apprentices and trainees claiming these subsidies will need apply directly to CTF for reimbursement.
